Passport Requirement Check List

- Passport application (form DS-11 -OR- form DS-82) must be completed in **BLACK INK ONLY** and **NO WHITE OUT**.
- Proof of Citizenship: Original Birth Certificate (Abstract Birth Certificates are not accepted) -OR- Certificate of Naturalization -OR- Previous Passport **with Birth Certificate for Children under age 16**.
- Valid photo I.D. (Applicant or parent(s) of a minor). *ID other than a Driver's License must be accompanied by a secondary ID.*
- A copy* of Birth Certificate **or** Certificate of Naturalization
- A copy* of the applicant's I.D. (if 15 years of age or older) **or** both parents' I.D.'s.
- Payment to the Department of State (**Check or Money Order ONLY**)
- Payment to the City of Pomona: \$25 application fee (waived if eligible to use the form DS-82) in the form of Cash, Check, or Money Order. **NO DEBIT/CREDIT.**
- Passport Photos (1) (*Available for additional \$12 fee*)
- Children under age 16 must have both parents present with them during the appointment. If one parent cannot be present, a notarized form DS-3050 must be provided with a photocopy (front and back) of the unavailable parent's ID.

*Copies can be made by the City Clerk's Office for 25 cents per page (with a minimum of \$1.00)

- Please have your application completed prior to arriving for your appointment time (use black ink only and no white out). Applications can be provided by the City of Pomona City Clerk's Office or obtained online at: <http://travel.state.gov/>. If you do not have the application completed prior to your scheduled appointment, please arrive at least 15 minutes prior to your appointment to complete your application.
- Parents and children must be present with all required materials to begin the application acceptance process. Appointments are recommended for Passport application acceptance. Please call if you need to reschedule your appointment or if you are running late. Appointment times are not guaranteed for late arrivals.
