

#### **COMMUNITY PERCEPTIONS AND PUBLIC RELATIONS**

#### 1.A. Is it relevant? Yes

- Contrary to some perceptions, not all homeless people have mental health issues (only about 1/3)
- Correct perceptions lead to correct solutions
- It affects civic pride; it's a reflection on the community.
- Public relations assists accurate perceptions/analysis. Do the underlying human issues to be addressed.

## 1.B. Does it need to be defined further? Yes

- Cannot separate homelessness from affordable housing.
- Different organizations have different numbers and definitions. Need to decide on a common one and be able to articulate why/how city or PUSD numbers are different.

## 2.A. What data is available?

- Messaging needs to focus on what is happening, not on what is not happening.
- From 2013 report we know that this issue is <u>ours</u> to solve (i.e. 65% of homeless are connected to Pomona having either lived or worked here. This leads to taking responsibility, feelings of ability, and making an impact.

### 2.B. What data do we need? Are there gaps?

- Need to have antidotal stories to go with data. Need both. Need to communicate the human side.
- What is Pomona's percentage of homelessness against total vs. other cities. Size and socio-economics makes a difference. Pomona has more poverty, which in turn engenders homelessness.

- PUSD is very open and willing to help distribute information.
- Chamber of Commerce has over 300 in its network.
- Social Networks like NextDoor, Nixle, Facebook, Twitter, etc.

### 3.B. What resources are needed for communications and public relations? Are there gaps?

- Could be using students and service learning more
- Need to remember not everyone has computers at home or smartphones.
- Short video clips that could be posted on websites.
- Need to make sure websites are user friendly and our message is easily accessed (not four pages down).
- Need to do PR and work with the homeless population we are discussing to let them know our intentions are positive, etc. Only in this way can we increase the likelihood they will access services.
- Make the message "win/win." There is no "we/them." The homeless are residents too.
