**5-DAY NOTICE OF A PUBLIC HEARING & COMMENT PERIOD FOR  
Draft Amendments to the Citizen Participation Plan and the 2019-2020 Annual  
Action Plan (AP)**

**NOTICE IS HEREBY GIVEN** that the City of Pomona has prepared Draft Amendments to the City's Citizen Participation Plan and FY 19-20 Annual Action Plan as required by the United States Department of Housing and Urban Development (HUD) to include provisions for **Coronavirus Aid, Relief, and Economic Security Act (CARES)** funding.

**What is the Coronavirus Aid, Relief, and Economic Security Act (CARES)?**

On March 27, 2020, Congress passed the CARES Act. The Act will support preparation for and response to the COVID-19 pandemic and its impact on communities. The City of Pomona was awarded additional funding for the following programs:

- Emergency Solutions Grant (ESG-CV) Program – (\$629,131)
- Community Development Block Grant (CDBG-CV) program - (\$1,221,892)

The Citizen Participation Plan describes the revised period of notification of a public hearing and receipt of public comments.

The Annual Action Plan describes the proposed allocations of CARES Act funding for CDBG-CV and ESG-CV Programs, and the Reallocation of HOME Program Funds to activities to facilitate urgent needs and assistance to families experiencing financial hardships. Activities must meet the goals and objectives of the City's 5-Year Consolidated Plan.
