

RESOLUTION NO. 2015-78

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ADJUSTING SALARIES PURSUANT TO THE PROVISIONS OF THE 2014-2016 POMONA POLICE MANAGERS' ASSOCIATION MEMORANDUM OF UNDERSTANDING

WHEREAS, on August 4, 2014, the City Council adopted Resolution No. 2014-95 adopting the 2014-2016 Memorandum of Understanding for the Pomona Police Managers' Association (PPMA);

WHEREAS, the City has subsequently amended the PPMA Memorandum of Understanding by Resolution No 2015-7; and

WHEREAS, the City desires to further amend the PPMA Memorandum of Understanding by increasing salaries by 2.5% in accordance with the PPMA MOU.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Pomona as follows:

SECTION 1. That in accordance with the PPMA MOU for 2014-2016, the salary scales for the classifications of Police Lieutenant and Police Captain shall be increased by 2.5% effective October 1, 2015 to maintain the following salary alignment:

Police Lieutenant 20% above Police Sergeant
Police Captain 15% above Police Lieutenant

Police Captain	PM-0020	10283	10811	11367	11943	12558

SECTION 2. That if any portion of previously adopted resolutions concerning salaries is inconsistent with this Resolution, the provisions of this Resolution shall prevail.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.




