M. on May 18, 2015 for the furnishing of all plant, labor, materials, equipment and incidentals for the: "Playground Rehabilitation – Memorial Park and Hamilton Park, Project No. 428-71025." It is the bidder's sole responsibility to see that the proposal is received in proper time. Any proposal received after the scheduled closing time for receipt of proposals will be returned to the bidder unopened.

The words "Bid: Playground Rehabilitation – Memorial Park and Hamilton Park, Project No. 428-71025," to be opened on 10:00 A. M., May 18, 2015 shall appear on the envelope of each sealed bid and each sealed envelope shall be addressed to the Purchasing Office, City Hall, 505 S. Garey Avenue, Pomona, California 91769. The proposals will be publicly opened and read in the Purchasing Office Basement, City Hall, 505 S. Garey Avenue, Pomona, California at 10:00 AM on the aforementioned date.

### **Submittal Instructions:**

Proposals shall be submitted in sealed envelopes and marked "Playground Rehabilitation – Memorial Park and Hamilton Park, Project No. 428-71025." One (1) original and one (1) hard copy of your proposal must be received in the Purchasing office (basement level) before the time of 10:00 A. M. on May 18, 2015. Any proposal that is to be submitted via hand delivery either through FedEx, UPS, or some other carrier service is to be submitted to City of Pomona, Purchasing Division, 505 South Garey Ave., Pomona, CA 91766. The above time and date are fixed and extensions will not be granted. The City of Pomona does not recognize the U.S. Postal Service, FedEx, UPS or any other carrier as its agent for purposes of receiving proposals. All proposals received after the deadline shown will be rejected.
